1. Welcome Welcome & Apologies/regrets.

2. Updates on Australia & British Columbia

Roianne to give brief Australia update (if present), BC (if present) will give brief update re: license holder changes (Anna and Deirdre to fill in if they aren't able

to attend).

BC: transfer of license from Ministry of Health \rightarrow Provincial Health Services Authority. Finalizing agreements and working through transition, solid team excited to be part of the work.

Australia: working through leadership changes/challenges – Gail in Australia in August, September, and October – supporting their team. Updates to come.



Update on CAG, Education Leads, & Data Analytic task & finish group/ work plans **Education leads** – regional guidance document \rightarrow how program supports mothers whose children are taken into care.

- Initially we were thinking this would be a QI paper and submission for Child abuse & neglect special issue
- We are not submitting anything to the special issue due to deadline constraints/capacity/general plans for this project.
- Deirdre to continue this work forward with listening sessions. Deirdre has some nominations of teams who have agreed to meet to discuss this further.

Carolyn's comment: keen if there would be in-depth discussion with one or more supervisors to understand how they can support a mother who has lost care of child – what support are they providing, for how long, etc.? – would be helpful to understand variation across each country.

- What is it that FNP can offer?
- As far as guidelines go understanding FNP's role. not prescriptive guidelines, just more of understanding what works for each country.

Data Analytic group:

- Looking at work done in Task & Finish Group from earlier this year, with intentions to look at and revise reporting requirements for phase 4 and 5 (this would be happening probably next year) David keen to get clinician's views on this as well.
- This work will be taken forward in the coming year. Carolyn's comment:
 That is helpful to hear. Just to say we are looking at what we will provide
 this year, and will be identifying what we might use in our country as a
 summary report as the data is so detailed and comparability is a bit of a
 challenge Scotland working on summary report translating to a wider
 audience
- Looking at definitions regarding eligibility and referrals in Task & Finish group earlier this year.
- Lynne: Importance of demonstrating impact on health inequalities
- Lindsay: Homing in on what indicators are most important for them, we should really look at what's showing impact regionally
- Northern Ireland: currently looking at social complexity within pregnancy

Clinical Advisory Group: no major updates from CAG – Lindsay presented about Family Planning Clinical pathways in May, Roianne to give a presentation re: First Nations Innovations, and Sara Lynch from the NSO to give update re: STAR at September meeting.

4. Scotland, Norway, and Ontario share on peer review process.

Sharing about annual report process! ~10 minutes each per country, informal verbal update.

Some key reflections between Scotland/Norway:

- Opportunity to reflect on achievements in past year
- Longstanding working relationship already existed (Norway visited Scotland in October 2023)
- Some discussion around time constraints/language barriers, importance of understanding nuance of NFP delivery, which is where much of our key learnings happen.
- Understanding what this group is going to do with the output from the peer review process what happens next?
- Difficult to see value of a phase 3 country reviewing a phase 5 country overarching question

Lynne: connected to Carolyn's comment re: outcome of review process-- from a governance perspective, having trouble understanding the purpose of sharing reflections – something to explore further...

Lindsay's reflections:

- Immediate feedback to one another via email, have someone facilitating meeting who is not the person presenting
- If someone puts in a request for a variance what are the next steps? Seeking clarity on this piece and emphasizing the "what happens now" element of the process.

Overall: Big undertaking in limited time frame. Lots to absorb and complete in a thorough way – decisions about variances etc., future planning for next 12 months, -- some sort of executive decision making. Can't tackle all of this just in



one hour meetings. Agreed that we need to pick up learning from this and adjust/improve guidance with how process flows. Where can international team take some of the heavy lifting?

Lynne: deeper questions regarding autonomy
